Supervisor Miller, on one hand you reach out with a training announcement to me, and on the other, the "Board of Supervisors" recently communicated to representatives in Harrisburg to have me disavowed as a Constable. Obviously, these two contradicting behaviors make it very confusing for me to understand what it is that you want.

FYI, I have written proof of this attempt to disavow me by the BOS. So, I caution you that if your next step is to bring in a member of a Constables Association or another Constable to a BOS meeting, you should know the following before doing so...

The solicitor for one of the Constables associations has been turned into the PA Bar for libelous comments following the BOS communications to Harrisburg. Other association leadership is facing felony charges for things like perjury and creating illegal search and rescue teams to skirt the law. A local regional director has been identified as not fulfilling his statutory duties to be at the polls during elections because he wanted to get paid. Be aware that these associations are not State Boards of Constables. They are only membership groups that have no authority over anyone and are seemingly only interested in lobbying for their legislation and performing secondary Constable work for the courts. I would be very cautious if you still plan to invite one of these associations to an upcoming BOS meeting to explain what a Constable does. I am not a member of these associations. I am a Constable and I can explain what I am going to do and what a Constable does. If you go that path, I am prepared to blow the lid off of them and your BOS if you do so. Respectfully, I don't think that is the type of attention our township needs right now.

Something to think about for you: If the person you were handing out cards for to vote as write-in Constable would have won the election, would you have taken issue with him being on the agenda, having his website linked on the township site, or even his phone number available for his community?

FYI, I did not respond to an accident scene on LGVR.

Individually, we are certainly able to research the position of constable.

As for the discussion of constable at upcoming meetings, I personally have no plans to have a different constable or constable association speak. I can't speak for the other two supervisors. In my own research on the subject, I have discovered that there are so many varying opinions even with in the constable associations as well as the government. What concrete information I do have, is what the PA State law regarding constables says. At the upcoming meeting, when we get to the unfinished business regarding the constable, I intend on having you share with the BOS what you believe the purpose and responsibilities of your position are. Will you be available for that? Again, I can not speak for the other supervisors. Thank you for passing along that information.

The boards that give regular reports at the Board of Supervisors meetings are boards that are directly tied to the responsibilities of the BOS and running the business of the township. The business of the township does not include the constable, therefore does not fit the expectation for a regular report. You are welcome to notify us if there is something pertinent to the business of the township to report on or be placed as an agenda item at our discretion, otherwise you certainly can use public comment time to speak about your position.

I respectfully request a reconsideration of this Final Determination for the following reasons:

1) The township has not provided ANY text messages responsive to this request. The township claims to have interpreted the request as having a different date range. In #6 of Jennifer Snyder's Attestation, she attests that she "provided all such information between December 1, 2017, and January 5, 2018." She has not provided ANY text messages from the time span I asked for, nor has she attested to searching for records responsive to that part of the request. In the Solicitor's response, he states that "it stands to reason that Ms. Grove's reference in her request to '1/5/2017,' which preceded the start date on '2/1/2017,' was a typographical error." It was not a typographical error, as stated in my appeal. I submitted another RTK request on January 7th for more recent text messages, which she granted on January 9th (almost a full month before she provided records in response to this request). It is not reasonable to assume that I would request the same exact records twice in a row. If I had, I believe they would have said so during this appeal. Instead, they argued that I meant to type a different date span.

2) The township HAS provided cell phone usage records in the recent past that were NOT provided this time. I would be happy to provide those documents if this issue is reconsidered. There is no reason they would have had those kind of records months ago and not now.

3) I am able to download months of detailed call logs from Verizon Wireless. Jennifer did not say she checked the Verizon website for call logs. In #9 of Jennifer's Attestation, she states that "the Township does not receive 'phone detail,' as Ms. Grove suspects." Based on previous communications by her I believe this is a semantics game, meaning that Verizon does not MAIL her a copy of the phone call log. That does not mean a call log is not in her custody or control.

4) The township has a history of non-compliance with the Right-to-Know Law. The township has previously destroyed a requested public record after it was requested, ignored a court order to provide records within 30 days, testified to the court that records no longer exist (before finally providing the "nonexistent" records after a Motion for Reconsideration was filed), and has not complied with multiple OOR Final Determinations from months ago.

The records in question are:

- 2017 Minutes for Water & Sewer Authority Meetings
- Current Employee Handbook and Job Descriptions IF newer than 2012.

I am attaching the PDF of the responsive records Jennifer sent me. One page 1 under "OLD BUSINESS," a "part-time position township employee" was created by the Sewer Authority. It is then stated, "Laron requested Gil ask the Supervisors to write an approve a specific job description for this part-time water and sewer system maintenance township employee."

These are the ONLY minutes that were provided responsive to my request. There was no Job Description provided to me for this new position.

On page 3, the Board of Supervisors made a motion to update a policy in the employee handbook. *The updated employee handbook was not provided.*

I am seeking those three items in this appeal.

The Water & Sewer Authority meet in the municipal building's meeting room. The building is also known as the Old Gregg School. *The meetings are advertised by Gregg Township. There is no other place for the public to inspect records of the Water & Sewer Authority.* The authorities do not have a website. Water Quality Reports are posted on the Gregg Township website. There is no email address available for either authority. My husband asked for Sewer Authority Chair Gil Morrison's email address and it was not given to him. The phone numbers that were published on the Gregg Township website for these authorities are:

Gregg Township Water Authority Billing Questions: Integrity Accounting 814-422-8200

Water Board Tom Stitzer – Chairman 814-422-8642 Sewer Authority Board Gil Morrison – Chairman 814-422-8779 or 814-360-2276

I called Gil Morrison on March 22nd at 4:49 PM to ask him how someone would obtain the meeting minutes, since Jennifer Snyder only sent me one. He told me I called his private phone and suggested I call Integrity Accounting. Integrity Accounting is a private business that is literally 2/10 of a mile from the municipal building (across the main road). I have attached a map. I stopped in to Integrity Accounting on the way to the township office on March 23rd, and they told me they were informed there was a RTK Request for minutes, so they immediately sent the requested minutes over to the township. I assume Gil Morrison contacted Integrity Accounting after I called him, because Jennifer Snyder said she did not.

I have uploaded two videos of the Secretary/Open Records Officer asking my husband and I to fill out disruptive requests. I have also attached an attestation indicating when the videos were recorded. **[I originally tried to attach these videos to this email, so the attestation states they are attached.]** This repeated behavior by Jennifer Snyder is part of a

larger scheme to defame our characters, as retaliation for requesting public records. In the 2018-03-23 video, Secretary/Open Records Officer Jennifer Snyder admits she did not ask for these minutes to be sent over. She said the minutes were emailed to her after my husband asked for Gil's email address. She asked me if I would tell people if she gave them to me without a second RTK Request. I said I would, so she said I would have to fill out a 2nd (disruptive) request for them. After some discussion about the RTKL and the cost of appeals, she finally said she would email them to me. She has not.

It is possible the township will provide these records in the next few hours, or by mail, so that this Final Determination will be ruled "moot." I did check my mail today, but in a previous appeal (2018-0201) the township submitted argument by mail and I did not receive it until after the FD. Maybe the mail was extra-slow that time, but the OOR directed the township to provide a supplemental affidavit in 2017-1433, and the township took no action.

The township is currently publishing RTK Requests and Final Determinations on their website and Board of Supervisors meeting agendas. They are not publishing their responses or responsive records. [I requested an Advisory Opinion from the OOR on March 14th about this.] The township is also discussing the "burden" of my RTK Requests in public meetings.

The Chair of the Sewer Authority (Gil Morrison) has apparently decided to join in this retaliatory circus of drama (over public records requests). I also recorded this (<https://youtu.be/LA37LhIZRJ8>) at the Sewer Authority meeting on March 26, 2018. Relevant to this appeal, Gil announces that they are following the township's meeting policies. After I refused to make an announcement that I was recording, he announced he was recording. It appears he video recorded my husband and I attending the meeting. Shenanigans like this are typical at Board of Supervisors meetings, but I had never seen a stunt like this at a Sewer Authority meeting until I requested their minutes from the township.

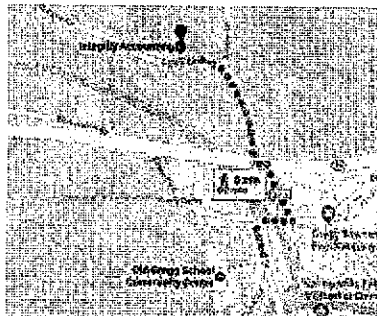
There are currently two OOR Final Determinations that have still not been complied with: **2017-0018** and **2017-1433**. In another case stemming from AP 2016-1837, the Court of Common Pleas directed the township to turn over the responsive records that were not destroyed after they were requested (the controversial record was destroyed). The township did not comply, and another hearing was requested to enforce the court order. The township then stated that the remaining records were destroyed long ago. After that hearing, Secretary/Open Records Officer Jennifer Snyder admitted to me that they were not destroyed, so a third hearing was scheduled. The township turned over the records at that point.

This is an ongoing pattern of Gregg Township, to make my husband and I jump through hoops for months or longer in order to obtain simple things like public meeting minutes. In a recent example, I submitted a RTK Request by email on the morning of March 27th that has not been responded to. It has been 6 days. That request is for records related to this, including: the recording Gil Morrison took of the meeting, and correspondence with a resident who was apparently told by someone that we have cost the township over \$10,000 in solicitor fees for RTK requests. That resident told me over the previous weekend that she was going to ask the township how much these RTK Requests cost the township, and that Monday she (the resident) announced that my husband and I have cost the township over \$10,000 (which is untrue).

Because of this pattern of noncompliance, I am asking the OOR to determine if this a "bad faith" denial (regardless of whether or not the township provides the missing records during this appeal).

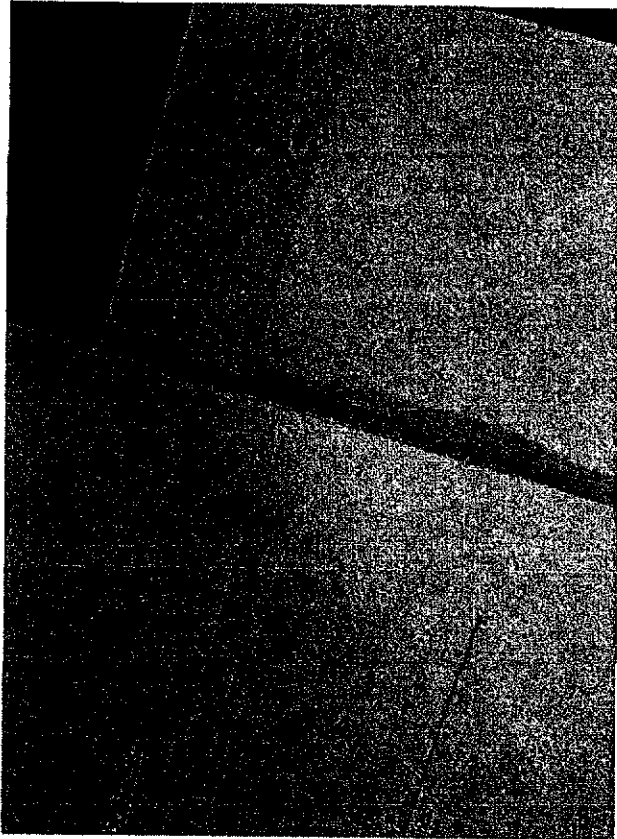

Just so everyone is aware of what is going on with this appeal, since Michelle feels the need to have an email petition for us to release these records, here is what is happening.

Michelle's RTK request asked for all Facebook posts, comments, and messages regarding R-18-02, video/audio recording, and "the Groves". I am asking for a reconsideration, based on the following:

- 1) As submitted, I attempted to get the minutes from the accountant prior to filing this appeal. I was redirected back to the township office to get the minutes.
- 2) As submitted, the accountant told me he did not have time to deal with RTK Requests.
- 3) In Section 502 of the RTKL, an AORO is "an official or employee" of the agency. The accountant is not a member of the authority, nor is he an employee of the authority. The authority has one paid employee (Laron Horner) who is on the township's payroll because the authority is not set up to pay employees (according to the township).
- 4) As submitted, the accountant's office sent the minutes to the township immediately after I contacted the Chair of the authority asking how I could get the minutes.
- 5) As submitted, the sewer authority meets in the township building and followed the township's meeting rules at the last meeting.

I understand that in *most* cases, the sewer authority is accessed separately. In a neighboring municipality, I have obtained minutes directly from the authority. Gregg township is extremely rural and this is a dead end. The accountant told me (before I appealed) that he could not fulfill RTK Requests. I cannot get records from the Chair. It appears to me, the accountant cannot even be the AORO.

Facebook was an example given to me by the Secretary when I asked her about this. She said Facebook usage could be personal or not personal, so the township would redact it. Another example given to me was the Secretary checking her personal email. Township owned computers are not personal devices. The computers are funded by taxpayers and the people who use them are paid by taxpayers. If they are spending 6 hours per day on Facebook or their own email, the public has a right to know. There is nothing I can think of that would be visible in the browser history that would meet one of the exemptions in the RTKL, nor did the township cite any exemptions in their response to me. If the Secretary logged into her bank account, for example, her password and account balance would not show in the browser history. I would only know she was on the bank's website.

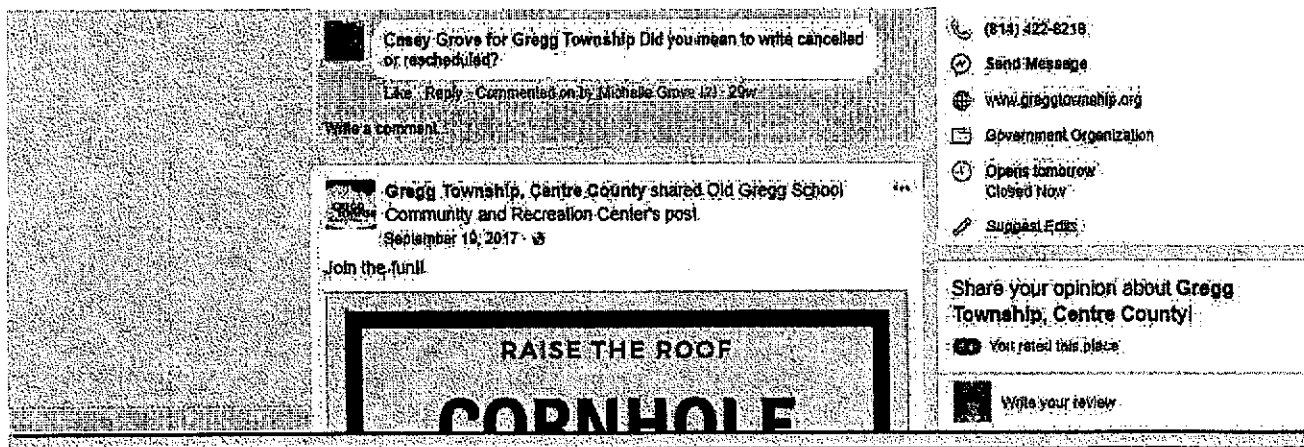

David,

I am in receipt of your letter dated May 15th regarding AP 2018-0556. As usual, your letter has a creative spin on the facts. "You made it clear throughout this process that you would like affidavits from every representative of the township" is false. I asked for an attestation from the Alternate AORO, who happens to have exclusive control over some of the records I have recently requested. This is no accident, as she is concealing records currently - maybe even from you, as you seemed to have no knowledge of the submission I made in the other appeal which included an email from her to Centre County as evidence.

At no point did Jennifer claim to have conducted a search of these records herself. "To be clear, you are already aware of these records." I was not aware of Cindy Grove's message to the Gregg Township page. I am aware of other correspondence and that is what I am seeking copies of. Sure I have some records already, but they were not provided by Gregg Township. Clearly the Alternate AORO is unwilling to provide an attestation under penalty of perjury. We will continue to litigate this issue if the township does not meet its burden soon. These recent requests are more important to me than the previous FDs the township has not complied with, so I am not going to let them slide.

While I have your attention, can you explain why the township told the Sheriff's Office and PSP (twice now) that they do not have surveillance of my husband's personal property being run over on four occasions? Jennifer told me they do and the footage is "saved." The Supervisors seem concerned about more recent vandalism, but are totally ignoring the evidence they have had for months (according to Jennifer) of repeat vandalism taking place on the township's property. Any other municipality would turn over the evidence they have been sitting on for months to the police, and consider the repeat vandal as their #1 suspect for the other vandalism. The only way it doesn't make sense to do that is if the township is protecting the repeat vandal

Additionally, Ms. Miller should follow her own advice and not be the only keyholder to her digital communications. She had a huge problem with Supervisor Stover managing a (private) donation account, and she directed the OGSAB to get township email addresses. It's in the minutes.
