## Joint Statement Concerning Constable Grove

### Two Statewide Constable organizations address concerns over a Newly Elected Constable

**Harrisburg, PA, February 2, 2018:** The Pennsylvania Fraternal Order of Constables (PAFOC) and the Commonwealth Constables Association (CCA), would like to make clear that Constable Casey J. Grove is not, nor has been, a member of either organization. It should also be noted that, according to the Pennsylvania Commission on Crime and Delinquency's records, he is not currently certified to perform court work in the Commonwealth.

While both organizations recognize Constable Grove's 1st amendment right to share his opinions we would like to clarify that they do not represent those of either group. We would hope that it is recognized that the constabulary is comprised of a great many honorable, hardworking professionals and that the majority, in no case, should be held accountable for the actions of the few or the one.
