Dear Parties:

**Please review this information carefully as it affects your legal rights.**

The Office of Open Records ("OOR") received this appeal under the Right-to-Know Law ("RTKL"), 65 P.S. §§ 67.101, *et seq.* on September 12, 2018. This letter describes the appeal process. A binding Final Determination will be issued pursuant to the timeline required by the RTKL. In most cases, that means within 30 calendar days. The OOR's Final Determination is currently due on October 12, 2018.

**OOR Mediation:** This is a voluntary, informal process to help parties reach a mutually agreeable settlement on records disputes before the OOR. To participate in mediation, both parties must agree in writing. The Parties agreement to mediate stays the Final Determination Deadline. If mediation is unsuccessful, both parties will be able to make submissions to the OOR, and the OOR will have 30 calendar days from the conclusion of the mediation process to issue a Final Determination, unless the Requester agreed to an additional 30 calendar day extension on the appeal form.

**Note to Parties:** Statements of fact must be supported by an affidavit or attestation made under penalty of perjury by a person with actual knowledge. Any factual statements or allegations submitted without an affidavit will not be considered. The agency has the burden of proving that records are exempt from public access (*see* 65 P.S. § 67.708(a)(1)). To meet this burden, the agency must provide evidence to the OOR. The law requires the agency's position to be supported by sufficient facts *and* citation to all relevant sections of the RTKL, case law and OOR Final Determinations. An affidavit or attestation is required to show that records do not exist. Blank sample affidavits are available on the OOR's website.

**Submissions to OOR:** Both parties may submit information and legal argument to support their positions by 11:59:59 p.m. on September 24, 2018. The record closing date is

seven (7) business days from the date of this letter unless the proceedings have been stayed for the parties to submit a completed mediation agreement form, then the record will remain open for seven (7) additional business days beyond the mediation agreement submission deadline. *Submissions sent via postal mail and received after 5:00 p.m. will be treated as having been received the next business day.* The agency may assert exemptions on appeal even if it did not assert them when the request was denied (*Levy v. Senate of Pa.*, 65 A.3d 361 (Pa. 2013)).

**Include the above docket number on all submissions related to this appeal. Also, any information you provide to the OOR must be provided to all parties involved in this appeal. Information shared with the OOR that is not also shared with all parties will not be considered.**

**Agency Must Notify Third Parties:** If records affect a legal or security interest of an employee of the agency; contain confidential, proprietary or trademarked records of a person or business entity; or are held by a contractor or vendor, **the agency must notify such parties of this appeal immediately and provide proof of that notice by the record closing date set forth above.** Such notice must be made by (1) providing a copy of all documents included with this letter; and (2) advising that interested persons may request to participate in this appeal (*see* 65 P.S. § 67.1101(c)).


Commonwealth Court has held that “the burden [is] on third-party contractors ... to prove by a preponderance of the evidence that the [requested] records are exempt.” (*Allegheny County Dep’t of Admin. Servs. v. A Second Chance, Inc.*, 13 A.3d 1025, 1042 (Pa. Commw. Ct. 2011)). **Failure of a third-party contractor to participate in an appeal before the OOR may be construed as a waiver of objections regarding release of the requested records.**

**Law Enforcement Records of Local Agencies:** District Attorneys must appoint Appeals Officers to hear appeals regarding criminal investigative records in the possession of a local law enforcement agency. If access to records was denied in part on that basis, the Requester should consider filing a concurrent appeal with the District Attorney of the relevant county.

**Public Record Notice:** All dockets, filings and OOR orders and opinions in this appeal will be public records and subject to public access with limited exception. The OOR’s Final Determination will generally include a summary of the case including the identity of the parties and the relevant factual background. Final Determinations are available on the OOR’s website and searchable on-line.

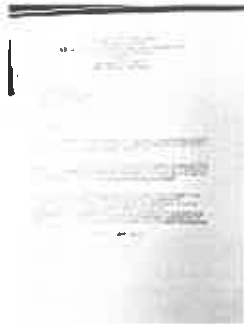

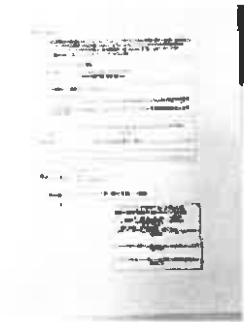

Gregg Township Supervisors,

At the February meeting, you will vote on R-18-02 "Meeting Policies and Procedures."

This resolution unreasonably restricts the behavior of the public, while giving the Supervisors the exclusive right to interrupt residents who are speaking. The "presiding officer" of the meeting will be empowered to "request" residents leave, have "disorderly" residents physically removed by law enforcement, and ban residents from future public participation at his or her discretion.

The aforementioned "Recording of Open Meetings Policy" mounts unreasonably high barriers to residents recording meetings, by requiring advance notice, limited movement, and the signing of a registry prior to recording. The policy further states the Board of Supervisors "shall" order residents to stop recording for a number of reasons, including recording in a manner which "distracts, disturbs, or is offensive" to any person in attendance. The "penalties" for non-compliance with this policy include "injunctive relief" with "the violator" paying "all attorneys' fees and costs."

I believe that the proposed township Resolution 18-02 (as-written) is not compliant or consistent with the PA Sunshine Act because of its presumption that registration or notice is required of a citizen to record public meetings.

With this proposed resolution the township creates unreasonable barriers to civic participation, by directly challenging a citizen's statutory right to record such meetings — a citizen is effectively prohibited from recording in the express manner intended by the Sunshine Law.

Lastly, the Injunction warning and termination of recording device warning in the resolution illustrates a fundamental misunderstanding of both the PA Sunshine Act and Wiretapping Act. Pennsylvania's Wiretapping Act prohibits recording an oral communication without permission where there is, "an expectation that such communication is not subject to interception under circumstances justifying such expectation." Simply, there is no expectation of privacy at a public meeting.

I am vehemently opposed to this resolution and policy. I urge you to vote against it.

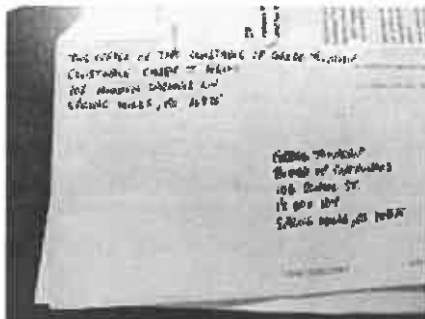

**LOWER GEORGES VALLEY BRIDGE CLOSURE UPDATE:** The 23-foot bridge that spans Muddy Creek on Lower Georges Valley Road (T-419) has been closed until further notice as a result of a recent, post-flood inspection. The township has been working with engineers and PennDOT on the bridge's deteriorating rating for over 10 years. The estimated cost of replacing the bridge is nearly \$2,000,000. Federal and state funding for the replacement of the bridge has been secured through the Transportation Improvement Program (TIP) for 95% of the cost, and the Centre County Commissioners have agreed to cover the majority of the 5% match required by the township for the TIP funding. Due to the amount of engineering and other elements necessary for the project, Penn DOT estimates that it may be two to three years before the replacement project is complete. Drivers should use Harter Road (T-464) and Penns Creek Road (SR2012) to access Lower Georges Valley Road.

Dear Supervisor Miller,

R-18-02, "Meeting Policies and Procedures," mounts unreasonable barriers and restricts in an unreasonable manner the participation of citizens at public meetings of elected officials in Gregg Township. By explicitly empowering the "presiding officer" of the meeting to "request" that citizens leave; by threatening (subjectively) "disorderly" residents with physical removal by law enforcement and allowing the presiding officer's to use his or her discretion to ban residents from future participation in such public meetings, the Township is creating an atmosphere of intimidation and hostility in its relationship with its citizens.

The "Recording of Open Meetings Policy" deters residents from recording meetings by requiring advance notice, limited movement, and the signing of a registry prior to recording. The policy further states the Board of Supervisors "shall" order residents to stop recording for a number of reasons, including recording in a manner which "distracts, disturbs, or is offensive" to any person in attendance. The "penalties" for non-compliance with this policy include "Injunctive relief" with "the violator" paying "all attorneys' fees and costs."

The Sunshine Act allows agencies to create reasonable rules that govern the conduct of public meetings, but R-18-02 is not reasonable, nor does it benefit civic participation and encourage democratic governance.

Section 711(a) of the Sunshine Act states:

"A person attending a meeting of an agency shall have the right to use recording devices to record all the proceedings."

It further provides:

"Nothing in this section shall prohibit the agency from adopting and enforcing reasonable rules for their use under section 710 (relating to rules and regulations for conduct of meetings)."

This provision, along with 710, allows agencies to create reasonable rules governing the conduct of public meetings, including the use of recording devices. Any such rule, however, cannot interfere with the statutory right to record meetings or the legislative intent to foster public participation and attendance at meetings. A policy that requires advance notice and permission from the agency in order to record a public meeting creates an unnecessary and unreasonable barrier to access and is contrary to the Law.

Legal challenges, expensive to defend against, are very likely to be mounted against the Township should the supervisors adopt this Resolution. Such defense of a Resolution – one full of seemingly unconstitutionally vague wording that creates pre-emptive barriers to exercise of statutory rights while threatening punitive actions against a Township's own citizens would be an extremely poor use of taxpayer's funds.

Please vote against R-18-02.
