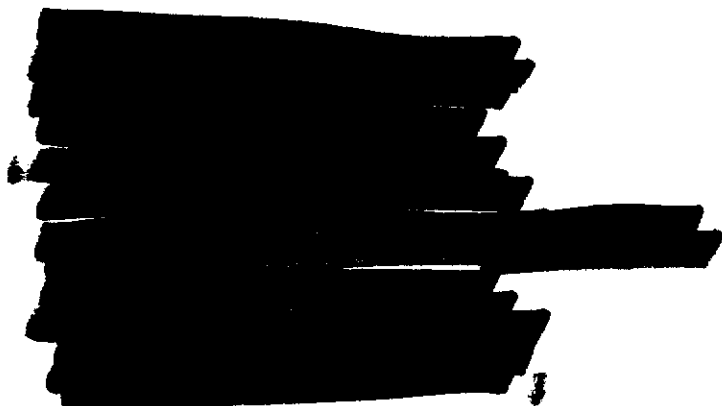

Unfortunately, Gregg Township has a documented history (including very recently) of not providing all responsive records to requests, and "should be" provides me, as the Requester, with no definitive answer. The township response does also not include an attestation made under penalty of perjury; nor describes the methods for the search, who was contacted for records & whether they all got back to the open records officer, and whether the server was personally reviewed by the open records officer. Please see the RTK Request form attached. I spoke with the Office of Open Records and discussed the situation and the relationship of the Penns Valley Code Enforcement Agency with the township. They feel that because you are a vendor or third party contractor doing a service for the township, you would not actually receive Right to Know requests but the township would be responsible to go to you to get the information and then provide that to the requester. With that said, I will need you to look at the request and get me the information. The only thing we have in our tax parcel file is two earth disturbance inspection reports. Once I receive the information from you, I would submit this information Mr. Lehew. Not sure about the cost of copies of plans like they are requesting and how much we would charge for them?

The OOR did state that under the Uniform Construction Code, some things like building plans are exempt and should be denied. We would need to state the UCC law that determines this. There may be other things not subject to RTK so we will have to deny those portion of the request as well. Are you familiar with any other things that might be exempt? David, any thoughts? I am thinking that maybe I should file a 30 day extension to allow you time to access these records and get them to the township? If I don't, our 5 day response time is Tuesday, April 10.

Pursuant to the state open records law 65 Pa. Cons. Stat. Secs. 67.101 to 67.3104, attached to this email you will find a public records request issued via a completed "Standard Right-To-Know Request Form." If your agency does not maintain the requested public records, please let me know who does and include the proper custodian's name and address.

I agree to pay any reasonable copying and postage fees of not more than \$25. If the cost would be greater than this amount, please notify me. Please provide a receipt indicating the charges for each document.

As provided by the open records law, I will expect your response within five (5) business days. See 65 Pa. Cons. Stat. Sec. 67.901.

If you choose to deny this request, please provide a written explanation for the denial including a reference to the specific statutory exemption(s) upon which you rely. Also, please provide all segregable portions of otherwise exempt material.

I would note that violation of the open record law can result in the award of court costs and reasonable attorney fees. See 65 Pa. Cons. Stat. Sec. 67.1304. In addition, denial of access to a public record that is made in bad faith could result in a fine of up to \$1,500. See Sec. 67.1305.

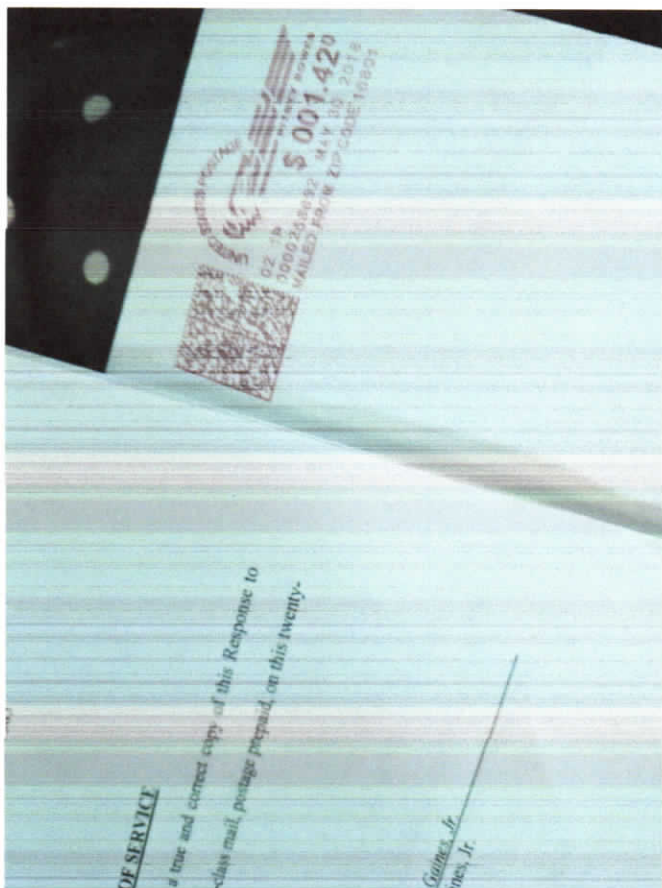

Ms. Zeppos,

Thank you. I will address the township's submission:

Of the prior two requests mentioned by the township, only the second one was for that specified footage. The first request was for many hours of footage, with no event mentioned. While that appeal was going on, a decision was pending in an appeal to the Commonwealth Court for other security footage. The OOR denied that appeal based on the decision of the Court of Common Pleas, which had been appealed. [Exhibit 1]

I submitted a new request for footage of specific events, among other things. Arguing the first request is for the same records as the second request is like arguing a keyword email search is the same as a previous request for a month of emails, because some of the keyword emails are including in the month of emails. Not the same.

Onto the "second" (first) request for this specified footage... That matter was not settled by the OOR. The OOR dismissed the appeal as untimely because, during appeal, Jennifer Snyder attested she received the request six business days before the extension notice was sent (in different words). Since I accepted the extension letter as timely, not knowing prior to that what day she received the request, the appeal was dismissed. [Exhibit 2] I did ask the OOR to reconsider the matter, based on both parties' acceptance of the extension notice as timely. The OOR later denied my request for reconsideration, but affirmed my belief that I can request the same records a second time and appeal again (if necessary). [Exhibit 3]

The township states, in the "most recent response" the township tells me the footage "does not show footage of any campaign sign, campaign sign being run over, or being replaced along school street." If that were true, the township could have said so during any other the other appeals. The township is complaining about the cost of litigating this issue, yet they did not attest to this before. Instead, they claimed the video was exempt for many other reasons - none of which they have proven. This is illogical, and untrue in my belief. The township also did not offer to show me the footage to avoid litigation. That would have been the quickest, easiest, cheapest solution.

In fact, after the "second" (first) request for this footage, I was worried the township had deleted the videos. I had a police officer ask her. She told him she did not have any footage from that time. I called her immediately, and she told me she had "saved" the videos I was looking for. I confirmed she had "saved" videos of my husband's campaign sign being run over and replaced. She said YES. I asked why she told the officer she didn't. She said he didn't ask the right question. (See submissions I forwarded from the previous appeal that was dismissed.)

The Commonwealth Court ruled on the other request for footage on June 25, 2018, and the township has conveniently changed its story about the existence of this footage. To this day, the township has not provided the other footage I won. They are in violation of the Commonwealth Court's order. [Exhibit 4]

This is not the first time the township has changed its position on the existence of a public record, nor the first time they have disobeyed a court order. In XXXXXXXXXX, the township did not provide records or appeal. A Petition for a Writ of Mandamus was filed after 30 days, and the township claimed they could not provide the records because the records were destroyed. [Exhibit 5] The Judge ruled in their favor. The Secretary (Jennifer Snyder) later admitted they were not destroyed. After a Petition was filed for a Reconsideration, the township produced the two recordings.

The township's attestations are simply not reliable. In a pending appeal with the OOR, the township attested to the accuracy of an exemption log. I submitted one of the emails described as something is was not. The log, attestation, and screenshot are attached. [Exhibits 5]

I will address Jennifer's Attestation:

5-8. Jennifer is not required to work with the solicitor. The solicitor budget is blown because the township 1) uses the solicitor for everything RTK-related. 2) Fights the release of records. 3) Disregards court orders and OOR Final Determinations. I could also whine about the amount of money my husband and I have spent on township-related

"issues" and attorney's fees. It's not relevant in this matter.

11. The township should not have denied this request based on my previous request. The matter was not settled. The only remedy I have to the OOR's previous dismissal is to request the records again. The township would not be burdened if they provided the video(s).

12. She attests there is no "footage of a campaign sign or a campaign sign being run over." I attest she told me she has it, and the township claimed the footage was exempt. One of the exemptions claimed was criminal investigation. As noted during the previous appeal, the footage is of no investigative value. How can the township claim a record is exempt as criminal investigation, then later claim there is no video by that description? That makes no sense - records that don't exist cannot be exempt for that reason.

13. She is only describing one camera. There are at a bunch of cameras on the property. I have seen the security system. Campaign signs were placed in different areas on the property. She seems to claim none of the cameras capture any of those areas, but doesn't exactly claim that. "The surveillance footage is centered on the Old Greg School playground and parking lot" describes the viewing range of one camera.

If the OOR needs more information, perhaps the OOR can view all of the cameras' range in camera, and/or the "saved" footage from those dates. An in camera review of the records would reveal how many cameras Jennifer saved footage from (or is willing to admit to saving). Examining all of the camera angles in camera would demonstrate to the OOR what the full coverage of the building is, and prove whether or not footage is being withheld or was destroyed after my request. Or, the OOR could grant my appeal in full and the matter can be brought into the court system if the township doesn't provide the footage, or the correct footage, or has destroyed the footage. I request the OOR grant my appeal in full based on all of the information I have provided, and case law regarding the OGS's security footage.

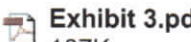

I am asking for a reconsideration, based on the following:

- 1) As submitted, I attempted to get the minutes from the accountant prior to filing this appeal. I was redirected back to the township office to get the minutes.
- 2) As submitted, the accountant told me he did not have time to deal with RTK Requests.
- 3) In Section 502 of the RTKL, an AORO is "an official or employee" of the agency. The accountant is not a member of the authority, nor is he an employee of the authority. The authority has one paid employee (Laron Horner) who is on the township's payroll because the authority is not set up to pay employees (according to the township).
- 4) As submitted, the accountant's office sent the minutes to the township immediately after I contacted the Chair of the authority asking how I could get the minutes.
- 5) As submitted, the sewer authority meets in the township building and followed the township's meeting rules at the last meeting.

I understand that in \*most\* cases, the sewer authority is accessed separately. In a neighboring municipality, I have obtained minutes directly from the authority. Gregg township is extremely rural and this is a dead end. The accountant told me (before I appealed) that he could not fulfill RTK Requests. I cannot get records from the Chair. It appears to me, the accountant cannot even be the AORO.
