The township wants to make me pay for hard copies because they claim the browsing history needs to be printed (on paper) and redacted to hide personal usage. Facebook was an example given to me by the Secretary when I asked her about this. She said Facebook usage could be personal or not personal, so the township would redact it. Another example given to me was the Secretary checking her personal email. Township owned computers are not personal devices. The computers are funded by taxpayers and the people who use them are paid by taxpayers. If they are spending 6 hours per day on Facebook or their own email, the public has a right to know. There is nothing I can think of that would be visible in the browser history that would meet one of the exemptions in the RTKL, nor did the township cite any exemptions in their response to me. If the Secretary logged into her bank account, for example, her password and account balance would not show in the browser history. I would only know she was on the bank's website.

I have not received a submission from the township, so I will try my best to guess what they have submitted. I would appreciate the opportunity to respond to what they have submitted, so I am requesting an extension of time.

I am seeking footage of a campaign sign being run over on four occasions and replaced. The township, to my knowledge, did not report this vandalism to the police. I requested documents related to that to prove this. There is no criminal investigation happening. I believe an associate of theirs (possibly an employee) was running over my husband's campaign signs and they were having a good laugh about it. That is why I have requested the videos.

The Commonwealth Court has already ruled their security footage is not exempt from disclosure. The township does not and has not investigated this, nor have they initiated an investigation to my knowledge. I have been trying to get these videos for awhile. My previous appeal was denied by the OOR per the previous court ruling that I won on appeal.

Ms. Higgins,

I will first address the "Legal Argument" submitted by the township:

"A. The Appeal Should Be Denied Because the Request Requires the Township to Create A Record."

"B. The Appeal Should Be Denied Because the Security Footage Is Exempt Under P.S. § 67.708(b)(2)."

"C. The Appeal Should Be Denied Because the Security Camera Footage Is Exempt Under P.S. § 67.708(b)(3)."

The Commonwealth Court already made a determination on this issue of security footage at the Old Gregg School. It is attached. The related FD can be viewed here: <https://www.openrecords.pa.gov/Appeals/FinalDetRecord.cfm?docket=2017-0159> The township claimed these exemptions before.

"D. The Non-Video Records Sought Relate to a Criminal and/or Noncriminal Investigation."

The township is only claiming this exemption for the non-video records now. I requested these "non-video" records only to support my video request, to prove the township never reported or investigated the repeated vandalism. I will withdraw that part of this appeal since those are the only records they are currently claiming this exemption for. I am only interested in the videos at this time.

I will now address Jennifer's Attestation:

On 5/9/2018, at approximately 1:40 PM, Jennifer told me on the phone the requested surveillance video is "saved."

Background: I have been trying to gain access to this video footage since the vandalism began. Initially, I called the Sheriff's Office (who does not handle vandalism complaints) and asked if the Sheriff would mind asking the township if the area the sign was placed in was covered by video surveillance. If it was, I intended to request the footage immediately. The reason I wanted the Sheriff to ask is that I felt I would not get an honest answer and hoped he would. The Sheriff is closely related to a tenant/board member at the Old Gregg School (Carol Gingrich). I hoped the township would be honest with the Sheriff because of this familial connection with Carol, and then the Sheriff would be honest with me because the Sheriff and I get along fine.

When I heard back, I was told the surveillance cameras do not cover the area the sign was in. Because of this misinformation, I did not put in a request and the vandalism continued. The township never even addressed it. This is unusual, because they openly discuss other vandalism to the property on their FB page and in public meetings.

My husband's signs were run over several more times, and I replaced them with new signs. Eventually, a sign was also run over at our private residence. Sadly, that was not the first vandalism we experienced at our private property since filing RTK requests with the township.

Several months after the election, I decided to request this footage anyway. I suspected it did exist and knew it would be gone soon. Apparently, my suspicions were correct. The township denied my request for the same reasons they denied footage of a secret meeting in late 2016 (the attached Commonwealth Court reversal). The OOR agreed (attached FD), per the Common Pleas ruling that was reversed by the Commonwealth Court shortly after (attached). At the time of that FD, a decision by the Commonwealth Court was pending.

Frustrated, I spoke with Trooper Harris of the PSP to see if he could find out if there was still footage of these incidents or not. This was on the same day the OOR denied my appeal, May 9th. PSP contacted Jennifer Snyder by telephone to ask. According to Trooper Harris, the township claimed they only had surveillance footage going back to November 21st of last year. After Trooper Harris told me this, I called Jennifer at the office and asked her if she deleted the footage I requested. She told me she did not, and said the PSP "didn't ask the right question." Specifically, she told me they did not ask her about "saved" footage. I confirmed with her that the "saved" footage we were talking about is the footage I requested of my husband's signs being run over on four occasions. She said yes. I called Trooper Harris back and communicated this to him. He later got back to me and said the township does not have any security footage that would be useful for an investigation. That was fine by me, as I only contacted him to try to find out if the township deleted the records. (It would not be the first time.)

The point I am trying to make is that Jennifer has communicated to me that she has the records available, and they were "saved" using the parameters I communicated in my 1st request. The footage has no investigative value according to Trooper Harris, who I contacted for the first time on May 9th (more than six months after the vandalism, and after the 1st FD by the OOR) in an effort to find out if the footage still existed. No one is investigating this vandalism. My only interest is acquiring the footage.

With the updated information I was given by Trooper Harris and Jennifer regarding the existence of video, I submitted a more specific request (this one) in order to continue to preserve the record pending the Commonwealth Court decision which has now been made. To be clear, I am seeking footage of the sign being run over and replaced 4x. I don't know the exact times it was run over, so I provided windows of time to search. If Jennifer has not narrowed the footage down to those specific incidents (sign being run over and replacement 4x), I am happy to do it myself. If she has, then my request was specific enough to isolate the footage I am seeking.

Jennifer states in her attestation that the videos I have requested require disclosure of footage from the entrance to the building. She also states that no member of the public has full knowledge of the front door camera which records people entering and exiting the building. That is not true. The footage I obtained on two other occasions of other signs of ours being ripped down by township representatives (roadmaster and two supervisors) was from the camera recording the entrance to the building. Also, the footage I won from the Commonwealth Court includes footage from that camera. The township is trying to reargue the same thing, even though it has been decided.

In 33, Jennifer admits the township is unaware of whether there is an investigation taking place.

I swear under 4904 (penalty of perjury) that everything I have stated is true and correct to the best of my knowledge and belief.

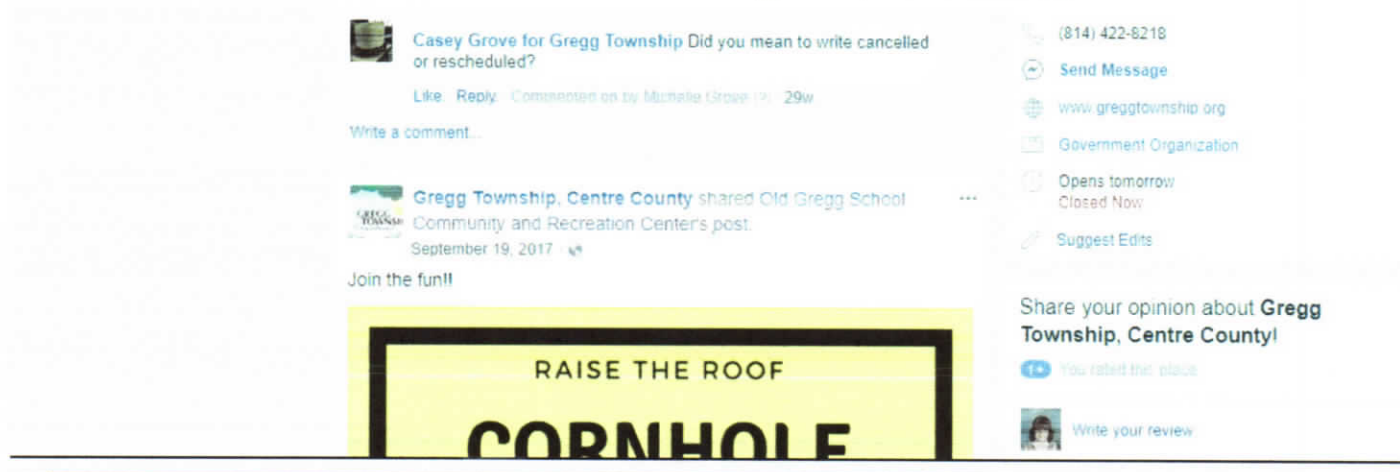

David,

I am in receipt of your letter dated May 15th regarding AP 2018-0556. As usual, your letter has a creative spin on the facts. "You made it clear throughout this process that you would like affidavits from every representative of the township" is false. I asked for an attestation from the Alternate AORO, who happens to have exclusive control over some of the records I have recently requested. This is no accident, as she is concealing records currently - maybe even from you, as you seemed to have no knowledge of the submission I made in the other appeal which included an email from her to Centre County as evidence.

At no point did Jennifer claim to have conducted a search of these records herself. "To be clear, you are already aware of these records." I was not aware of Cindy Grove's message to the Gregg Township page. I am aware of other correspondence and that is what I am seeking copies of. Sure I have some records already, but they were not provided by Gregg Township. Clearly the Alternate AORO is unwilling to provide an attestation under penalty of perjury. We will continue to litigate this issue if the township does not meet its burden soon. These recent requests are more important to me than the previous FDs the township has not complied with, so I am not going to let them slide.

While I have your attention, can you explain why the township told the Sheriff's Office and PSP (twice now) that they do not have surveillance of my husband's personal property being run over on four occasions? Jennifer told me they do and the footage is "saved." The Supervisors seem concerned about more recent vandalism, but are totally ignoring the evidence they have had for months (according to Jennifer) of repeat vandalism taking place on the township's property. Any other municipality would turn over the evidence they have been sitting on for months to the police, and consider the repeat vandal as their #1 suspect for the other vandalism. The only way it doesn't make sense to do that is if the township is protecting the repeat vandall

Additionally, Ms. Miller should follow her own advice and not be the only keyholder to her digital communications. She had a huge problem with Supervisor Stover managing a (private) donation account, and she directed the OGSAB to get township email addresses. It's in the minutes.

Hello. Just curious of your role in this process and what you mean by a legal appeal? Please let me know.

The very limited information we received in our initial request remains incomplete, missing pages, signatures with dates and raw information that is customarily on record as a home is built and property is manipulated.

We are looking for complete records...everything available and if not available, then some appropriate form of acknowledgement that the items are not based on the specific things we requested in the original RTK request and our follow-on correspondence. We need to know that our home's construction has sufficiently met regulatory requirements during the build—the normal regulatory checks and balances in place to protect us as the buyers and allow us to sell our home later. Otherwise, we lack very basic information on our home despite it having been constructed within the past year or so. We have little to go on when it comes to making changes to the land or structures or ensuring we are not future-labile for any past discrepancies should we decide to sell our home later.

It appears that the township is looking in part to a third party contractor to provide documents related to our property and that contractor is telling us that they are not required to keep most of what we requested. We would prefer that the township engage the contractor and any others needed to complete the request vice us to get one consolidated answer in response to this request rather than splintered information flow such as our obtaining the blueprints, which, at first the contractor felt compelled to seek legal council before releasing them, then charged us mileage, time and reproduction cost to obtain.

As far as the plans themselves go, we noticed that the plans are unsigned and do not include anything on major systems like HVAC, electrical or plumbing. Nothing on the second garage or drainage plans, etc. No plans or permits or inspections on the completion of the build or approved allowances for the very substantial deviations from the blueprint. There is nothing on the deck nor the second structure...these are in addition to/added details to the other items we mentioned previously.

We are not home-building experts and so I would ask that the township's experts proactively fill in any information blanks regarding customary data and records pertaining to this request.

Thanks for your help. Let me know if you have any additional questions.

Since an agency has 5 business days to respond from the time of receipt, I assumed the township's response was timely. I do not know when the agency receives the request. There is no read receipt emailed, or other acknowledgement of receipt.

The 30 day extension did not specify what day the township received the request. To my knowledge, the date of receipt was not specified until documents were submitted in **appeal**. T

Since both parties continued on with the request properly, it was clearly accepted by both parties that the 30 day extension was timely. I ask the OOR to reconsider based on our **joint acceptance** of the 30 day extension.

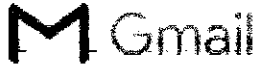
