The Old Gregg Advisory Board met on May 3, 2016 at the Old Gregg school, 106 School Street in Spring Mills, PA. The meeting was called to order by President Jane Burrows at 6:33pm.

BUSINESS:

MINUTES: Keri Miller made a motion to make two corrections to the minutes. (1) the Grapevine cost is \$275.00 a month and (2) the \$90,000 was for the new system, not repairs, with a second by Jim Smith. Motion carried. No further discussion.

OFFICER'S REPORTS

PRESIDENTS REPORT: Jane had two concerns. (1) Jen is now doing the Grapevine for us. She is being paid by Gregg Township. Jane is worried how the community views her doing this, and she thinks we should not ask much more of her, since she is an employee of the township. (2) Is Doug still comfortable doing all the repairs/maintenance or would he like one of the advisory board members to help him, when possible. Doug said that he and Joel had been discussing that. They were talking about the possibility of them hiring a "Guy Friday" who would go between the township and the road crew. This is currently just in the talking stage. During the discussion Doug talked about the estimates for the repairs on the steps and that they were looking at writing specs for those repairs. Doug handed out the OGS Maintenance Projects sheet by priority. Charles said again that maybe someone within the Advisory Board could help. Jane asked Jim Smith if he could help with the repairs on the little things, so that Doug could continue with other projects. Jane's additional concern was Laron being paid by the township but doing repairs for the building. It was explained that his work could be billed differently. Jim is willing to help with the maintenance and will start helping immediately. On the maintenance projects Doug was looking for a "blanket" approval. **A motion was made by Keri Miller with a second by Peggy Myers that we give approval for the stairs and the ramp work.** Motion carried. Doug also said that he had gotten a call from Jared Conrad, who works at the YMCA. He had called asking about the ball field. He was going to be having day camps at the Y for football and softball. Doug asked what he should charge him. Doug felt we needed to have consistent fees. The gym fees are currently \$2.00 a person. It was suggested that he uses that fee. The Board would see how the summer went and possibly make changes for the following year.

COMMITTEE REPORTS:

BUDGET: Doug reported that the budget continues to look better. Income was up.

MAINTENANCE/BOILER:

STEPS: That was talked about earlier during the Presidents report.

SUPERVISORS REPORT: Signs are in place. Bob Peese will open on Saturday mornings. The book bench was with the Food Center. It's currently stored on the stage till they are ready to place. The sign is ready to be placed at the ball field. Keri and Doug will walk down one day to look where would be the best place to put the sign.

PLAYGROUND (PLANS FOR GRAND OPENING) (SIGN) (PAVING): New mulch will be put at the little playground area. Keri reported the sign will be 5' wide 3' high. The back side of the sign will list everyone that donated to the playground.

SPECIAL REPORTS:

TENANTS: Nothing new other than the continued problems with parking.

FOOD RECLAMATION PROJECT: Keri reported they were not quite ready. They did have a pretty good turnout for the grand opening even though it rained. The Taproot Kitchen catered the food. Three of the old benches have been saved. Three could not be. They are in the cage by the Food Center and will be repaired and used by the Center.

FITNESS CENTER UPDATE: Nine new memberships in the past month. A better system needs to be figured out for billing fitness center renewals.

INTERNET UPDATE: WIFI antennas are in. Flashpoint needs to come in and program. Not operating yet, getting there.

LONG RANGE PLAN: Jane suggests that a committee be formed to work on this. Keri Miller, Jane Burrows, and Carol Gingrich volunteered to be on that committee.

OLD BUSINESS:

FUNDRAISER – JULY 30TH??? The Railroad wants to have their open house with the playground official opening. A craft fair for the kids, do a picnic with OGS doing the hotdogs and hamburgers. The Old Gregg School Advisory Board met on April 5, 2016 at the Old Gregg School, 106 School Street in Spring Mills, Pennsylvania. The meeting was called to order by President Jane Burrows at 6:31 pm.

BUSINESS

MINUTES: A correction to the minutes was given by Peggy Myers. On page 2, it was said that Doug Bierly was not being paid, when in fact he is. It is being looked into increasing his pay. **A motion was made by Peggy Myers, with a second by Carol Myers to approve the minutes with the correction.** Motion carried, no further discussion.

VISITORS Ann Walker/Elody Gyekis – Book Bench Project: A presentation was given with an offer to donate a bench to the playground. The bench is 48 ½” wide and 36” deep. It weighs 50 lbs and will be bolted to a slab. After much discussion concerning the wording on the bench, **a motion was made by Carol Myers to keep the bench, but not to place it at the playground, it will be placed at the Food Centre when completed.** All were in agreement. The bench will also be kept on the stage until it can be formally placed.

OFFICERS REPORTS

PRESIDENTS REPORT: Jane Burrows reported on several items. Keri Miller will be maintaining the Facebook page. Jennifer Snyder will be taking over the Grapevine page, which costs \$275.00/year. She will be doing this on her own, with no charge to the Board. The supervisors in attendance were ok with that. All information for the ad is due by the 15th of every month. An email will go out to tenants advising on the time frame. We are in search of someone to maintain the website. It was suggested that something be put in the Grapevine for that. Jane Burrows suggested that something be done for Carol Yeagley and Robin Bastress, who were both instrumental in organizing and maintaining the advisory board. Peggy Myers will look for thank you cards for them until something more formal is done.

COMMITTEE REPORTS

BUDGET: Income is continuing to be coming along and holding steady.

MAINTENANCE/BOILER: Doug reported that it’s looking like a minimum of \$90,000++ for repairs. McClure would like to come and present a proposal to anyone from the board that’s available. Looks like Thursday, April 14th works the best. Doug will send out an email with the time.

LIST IN ORDER OF IMPORTANCE MAINTENANCE ETC. AT OGS: Looks like right now the most important is parking and the boiler. All are asked to think about this till the next meeting in May.

STEPS: Doug reported that Gary Horner (571-5767) is working on an estimate. Chris Kunes has given a quote just on the bricks. It was suggested to try again to call Rick Boone (422-8658) and Arlan Kauffman (349-5398) for estimates.

SUPERVISOR’S: Doug continued with this, as it includes what committee reports have already been given.

PLAYGROUND (PLANS FOR GRAND OPENING) (SIGN) (PAVING): Nothing new on the sign. Keri will try to touch base with Chris Kunes again. The lowest estimate for paving was received by Eby for \$18 or \$19,000.

SPECIAL REPORTS

TENANTS: Parking is becoming a concern for some of the tenants.

FOOD RECLAMATION PROJECT: We need to keep tabs on this project as things keep changing with not much communication to the board or the supervisors. An example was the basement was to just be for storage, now it’s going to be a work area with a sink, and now a pergola has been added to the end of the containers, which was not discussed. Keri is now a part time employee, so she’ll have a better insight and can report to the board.

FITNESS CENTER UPDATE: Interest and memberships keeps increasing.

FOOD FOR PROFIT COURSE REVIEW: Carol Gingrich reported, as she attended the course. The course was a big success. Many of the attendees were very interested in our kitchen. The course was attended by 15+ with speakers making the total closer to 20. The attendees were very impressed with the OGS building and all that happens here.

INTERNET UPDATE: All is still in progress. Hopefully within the next week or two all of the routers will be installed. Each room will have its own secured router and individual password. The routers are owned by OGS.

LONG RANGE PLANS: It was asked by all to be thinking about prioritizing what needs to be done till the next meeting in May. At this point all were in agreement that the parking and steps were two of the biggest undertakings. Keri feels we should think about hiring someone to help with a master plan for OGS. All has been tabled until our May 3rd meeting.

OLD BUSINESS

SECURITY SYSTEM UPDATE: The newest camera in the gym is working fine.

CRAFT FAIR/FAIRS – APRIL 30TH?? AND FUTURE CRAFT FAIRS: After a long discussion it was decided to skip the April craft fair as the Food Centre would be probably using the gym. The Old Gregg School Advisory Board met on February 2, 2016 at the Old Gregg School, 106 School Street in Spring Mills, Pennsylvania. The meeting was called to order by President Jane Bailey at 6:39pm.

BUSINESS:

MINUTES: A motion was made by Carol Myers, with a second by Peggy Myers to accept the minutes from January 5, 2016. Motion was carried. No further discussion.

OFFICER'S REPORTS: Jane Bailey thanked Peggy & Don Myers for their generous donation to Old Gregg School.

Bumped up Kevin Sims and Adam Seitz from the Special Reports: FOOD RECLAMATION PROJECT: Kevin Sims supplied a sample budget along with a projected calendar out for all to review. In the budget, the extra \$22,000 is for focusing on the Penns Valley site. They have learned that they will be able to have their own meter for the electric. Adam Seitz then gave his report on the proposed changes to the lease, where it concerns the Food Center. Several modifications were added and also different parts of the lease agreement were also clarified.

COMMITTEE REPORTS:

BUDGET: Doug Bierly reported that the income is greater than expected. OGS is doing very well. **A motion was made by Carol Myers to accept the budget, with a second by Peggy Myers.** Motion passed. No further discussion.

MAINTENANCE: Doug Bierly double checked the drains on the roof as asked by Jane Bailey, at the January meeting. They are all clear and all are open.

BOILER UPDATE: Doug Bierly reported that McClure Company were working on the hot water shutoffs when it was determined that they were leaking. Work has been stopped until they can come back and shut the system down. This is still included in the contracted \$3968. The solar system is working well and doing what it is supposed to do.

PLAYGROUND (PLANS FOR GRAND OPENING): Keri reported that all is still up in the air. Possibly looking at a grand opening in June.

SUPERVISOR'S REPORT: Nothing additional.

SPECIAL REPORTS:

TENANTS: It was suggested to possibly be thinking about renting out the display case, that's in the lobby area. **A motion was made by Keri Miller, with a second by Carol Myers to develop a policy on renting the case.** Motion carried. Peggy Myers and Carol Gingrich will develop a policy and report back at the March meeting.

FITNESS CENTER (door with lock): Keri Miller reported \$730 in memberships. With additional income of \$232 for the Underground. It seems that making that area formal seems to have helped dramatically. There was some discussion on possibly selling t-shirts as a fundraiser for the Underground. All were worried that the YMCA would have an adverse effect on the center, but that doesn't seem to have happened. If anything it has helped. Carol Gingrich is to have Dave Sampsel get with Doug Bierly as to the progress of installing the door. There was one accident to report with nothing that needed to be done at this time.

FOOD FOR PROFIT COURSE: Adam Seitz reported that the date of March 25th was still a go for the course.

INTERNET UPDATE: Doug Bierly spoke with Dave Gibbens as to the cost to add additional equipment in the gym, library, and room 106. We're probably looking at close to \$1200. Adam Seitz is going to double check with Flashpoint if the routers are included. The Supervisors will move forward concerning the additional costs at their next meeting.

OLD BUSINESS:

FUNDRAISERS: It was reported to look into having a 10-year anniversary event, possibly tying in with the playground opening. Jane Bailey will help with bringing some information, along with Joel talking to Greg Evans, as he has been working on upgrading information on Gregg Township. Some thought maybe a new book was warranted Joel will move forward with that, with Greg. All would be celebrating the past, present and future of OGS.

SECURITY SYSTEM UPDATE: It was suggested that we look into adding an additional camera in the gym area. It would be easier to see who is using the one set of doors.

CRAFT FAIR – MARCH 19, 2016, 9-12, WITH EGG HUNT AT 10: More to come on this in the GrapeVine.

NEW BUSINESS:
