Doug, Here is the answers to Michelle's questions.

The \$258.55 income from the General Fund to the Old Gregg School was for an expense to the Penns Valley Builders that was inadvertently paid from out of the Old Gregg School but in fact it was an expense for Gregg Township. So someone transferred the \$258.55 from the General Fund to the OGS. The expense would have been in the OGS Building Maintenance column when they paid the invoice for Penns Valley Builders so they could have credited the expense column for building maintenance as opposed to showing it as an income but it was in **2009** and we can't go back and change it. It was a clerical issue. The General Fund expense was in 438.140 Repair Roads and Bridges - Salary. I have documentation for all of this but because it was not an expense to or from the old gregg school it was NOT listed on my report.

The \$89 is a deposit intended for the OGS which was inadvertently deposited into the GF and then later transferred to the OGS. You can see the supporting deposits and transfers.

Ms. Zeppos,

I am writing in reference to AP 2017-1433. I have attached the files that Jennifer (OOR Officer) sent me. She did not send all of the correspondence I requested. There should be 33 files. There is no correspondence between the contractor LEH and the township. Some of the emails state that there are no responsive emails in that box, yet they were copied on emails. See #22 and #5 for examples. I understand from previous verbal communications and discussion at meetings the township started setting up township emails in order to protect personal email addresses from RTK searches. Additionally, the township would have custody of all township-related emails. If the email addresses were set up to leave a copy of the emails on the township's server, all incoming emails (or all emails, depending on whether they used POP or IMAP) would be preserved and accessible by the Open Records Officer. Some of the board members and Supervisors did not even respond to the search. I am confident that more correspondence exists. The winning bid (LEH) does not even seem to have a cover page. That is very unusual. There is no correspondence between Mammoth & Doug Bierly about the revised quote prior to his receipt of the revised quote. Since they corresponded by email, I find it unlikely there is none. In #18, the email says Doug will let him know when the second quote came in and I do not see an email about that.

In response to the security footage portion of my request... I have acquired security footage from Gregg township in the past, so I am familiar with how the footage is formatted. First, I do not need the township to create a record. I can record the segment I am looking for on my phone, as I have done before. Second, they are filed by camera # and date/time, as anyone would expect. The camera I am asking for footage from is in plain view and is the same camera I have obtained footage from in the past - on two occasions. There are no trade secrets or security issues to protect, and Jennifer has not attempted to prove such. In response to her last reason for the denial (specificity), I can be more clear about what I am looking for. I am unsure of the exact time, but I am looking for the footage of people leaving the building after the public meeting. Specifically, I am looking for the footage of my husband and I walking out the front door. If she will locate that 30-ish seconds of the footage and allow me to "inspect" it (making my own copy), I will be satisfied with that portion of my request.

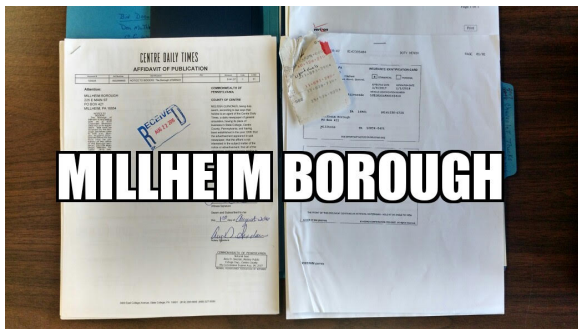

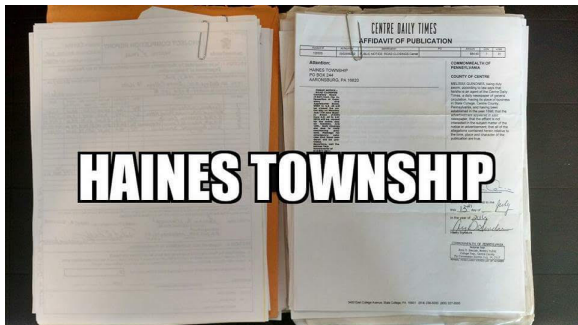
Supervisors & Jennifer,

I have been visiting other municipalities to inspect bids. I want to share my experience with you so that you can compare it to how you handled our requests.

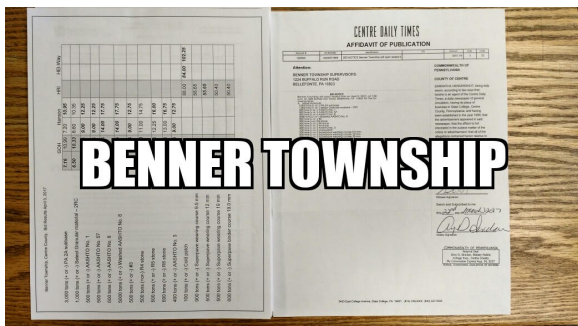
Millheim Borough - I walked in and was immediately allowed to inspect bids. I did not need to fill out a form.



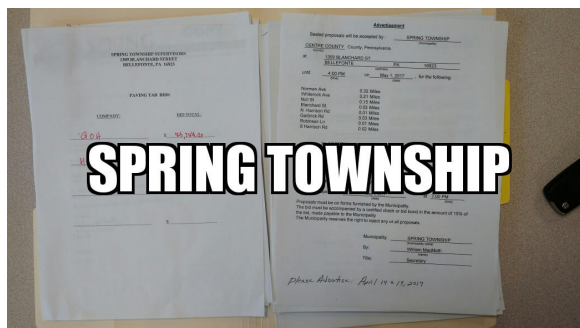
Haines Township - Same.

To make things interesting, I submitted a RTK Request with Potter Township for the last YEAR of bids. She responded the very next day.



Centre Hall Borough & Miles Township are closed.

Why did it take Gregg Township a full month to produce one single bid, and a month and a half to allow inspection of other bids? Jennifer's assertion that she had to spend a lot of time pulling these bids is untrue. When we finally inspected the bids on Monday, it was immediately apparent they had not even been opened. How do I know? Some of the folders (which were not bids we asked for) had to be literally CRACKED OPEN. There are multiple items contained in bid folders that should be filed elsewhere, such as login information, a registration sticker, and a photocopy of an ex-employee's driver's license. If Jennifer had looked at what she gave us, I am sure she would have noticed those things.

How is it that other municipalities with only one Secretary are able to promptly accommodate public records requests without drama, but Gregg Township is not? This is an embarrassment.

Stop playing these childish games. It is costing taxpayer money and tarnishing the reputation of the township.

Sorry for the delayed response, Jen just got my computer and phone reset up so I can get emails on the supervisor account. Response follows:

1. Appointment of board members The supervisors act on recommendations from the advisory board when they provide to us an individual that has been recommended to the board as was done in August of last year. We received no recommendations for any new members to be appointed to the board in the past few months. For the park board, we are having an open house this month for the park, currently have several township residents that have shown interest and hope the open house may attract others to become interested. No appointments will be made at least for another month.

2. Number of supervisors on the board for Gregg Township There are two ways for this to happen, since you know many residents that want to change this, residents can make this happen by following procedures that can be obtained at the court house. It takes a petition signed by township residents to start the process.. I will ask the supervisors at the upcoming meeting if they would like to have this on next months agenda as well. Keep in mind that the cost of adding 2 supervisors would be in the range of \$2500. I have talked to many about 3 vs 5 supervisors and one thing that has come back in discussions was that it slows the responsiveness of boards to dealing with normal business. However I would certainly accept the will of our residents if they voted in favor of adding two more supervisors. Generally the more highly populated townships, especially closer to State College have gone from three to five.
