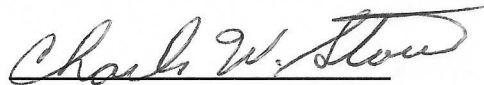

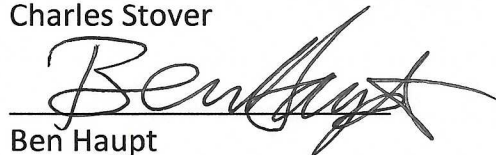

Land Development:

(All fees paid by Developer)

- Site Evaluation & Soil Test Pit Observation (4 per lot or EDU) \$225.00 per lot
(Hourly rate over 4hrs.)
 - Includes: Soil Test Pit Observation, Site Evaluation, and Inspection of Existing System.
- Percolation Tests per EDU (primary and/or replacement site) \$225.00
- Percolation Tests Primary AND Replacement, per EDU, if conducted at the same time \$325.00
- Plan and Component 1 Planning Module Review and Rereviews \$150.00
- Plan and Component 2 Planning Module reviews and re-reviews At hourly rate
- Verification of Prior Testing \$85.00
- Preparation of percolation test holes (digging per set of six) \$125.00
- Supply water per set of six holes \$125.00
- Conduct pre-soak per set of six perc holes \$ 60.00
- Project administration At hourly rate
- Plus Mileage Rate: Maximum IRS allowable rate

NON-RESIDENTIAL:

The Application fees for all non-residential Land Development will be based on the proposed sewage flow on and Equivalent Dwelling Unit (EDU) of 400 gallons per day equals one lot.

ON-LOT SEWAGE DISPOSAL SYSTEM DESIGNS:

On-Lot Sewage Disposal System designs will be completed at an hourly rate plus cost of copies, postage and mileage at the prevailing hourly rate for the Primary Sewage Enforcement Officer.

DEP SEWAGE PLANNING MODULE PREPARATION:

Sewage Planning Modules for Land development and Subdivisions will be completed at an hourly rate plus cost of copies, postage and mileage at the prevailing hourly rate for the Primary Sewage Enforcement Officer.

NON-PERMIT RELATED SERVICES:

All non-permit related services, unless previously specified, will be completed at an hourly rate plus cost of copies, postage and mileage at the prevailing hourly rate for the Primary Sewage Enforcement Officer.
