Discussed having celebration on either Oct. 10, 17 or 24th, 2026; Rededicate Veteran's Fountain; Gregg Twp Walking Tour; Have a PA System to make announcements; Chicken Bar-B-Q; Scavenger hunt of Gregg Twp properties; reach out to Historical Society; and have a Gregg Twp Game Show.

NEW BUSINESS:

1. Amendment to Dunkelberger's Installation and Maintenance Agreement. Renews on 4/19/2026.
2. Motion to approve Eric Levi's Minor Subdivision Proposal from Centre County Planning and Community Development Office
3. **Renaming 532 Synagogue Gap Rd to "Little Run Hollow"** (Entire road crosses through the Nancy & David Hosterman property and stretches into the neighboring Rummel/Bressler Property. Driveway is approx. 2,400 feet long and runs under a heavy pine canopy, making the two cabins invisible from the main road). Renaming of the road is to assist 911 respond in a faster time.
